## 公司业务

- 中国有色黄金有限公司("中国有色黄金"或"公司")·专注发展以金锭为主要产品的黄金业务·将成为中国有色矿业集团有限公司("中国有色集团")在中亚地区(包括哈萨克斯坦、吉尔吉斯斯坦、塔吉克斯坦、土库曼斯坦及乌兹别克斯坦)的主要黄金业务平台。中国有色集团为公司的控股股东·同时是中国国务院国有资产监督管理委员会("国资委")直接管理的国有企业。
- 公司于塔吉克斯坦拥有四个项目,包括旗舰项目帕鲁特项目、东帕鲁特项目、Rufigar项目及Sulfidnoye项目。帕鲁特项目现时处于开采建设阶段,其余三个项目处于勘探工作阶段。
- 公司拥有67,502千吨矿石的矿产资源,黄金含量为149,550千克;18,508千吨矿石的矿产储量,黄金含量为55,113 千克。
- 帕鲁特项目将分为两期进行·预期一期将于2014年12月开始试产·试产将由2015年1月至5月。届时一期的全面设计产能将于2015年6月达至2,000吨/天。二期将在2015年7月开始施工·预计帕鲁特项目于2017年6月的最终设计产能会达至4,000吨/天。
